LOCATION

Acel House is located circa 1 mile from J38 of the M6 motorway, just off the A685 Kendal to Tebay Road, at the southern end of the village of Tebay. Tebay is a small rural village some 16 miles south of Penrith and 12 miles northeast of Kendal.

DESCRIPTION


A modern industrial unit of steel portal frame construction with extensive ground floor offices. **Acel House** has infill blockwork walls at a low level to the office elevations with plastisol coated profile metal cladding above and to the insulated, pitched roof.

Internally, the property comprises two self-contained workshop/ warehouse areas together with extensive ground floor office and ancillary accommodation. There is also an area of first floor mezzanine storage. The workshops have an eaves height of 4.88m (16'). Vehicular access is provided by way of 3 no. sectional Up & Over shutter doors.

Externally, the yard areas are tarmac surfaced providing external storage and parking for 32 cars. The whole site is secured by perimeter palisade fencing with 3 sets of double gates.
